### Required Qualifications

#### Education/Training

Successful completion of an ACGME or AOA accredited Fellowship in cardiology or foreign equivalent training

**AND**

Current certification or active participation in the examination process leading to certification in cardiology by the American Board of Internal Medicine or by the American Osteopathic Board of Internal Medicine or foreign equivalent training/board.

#### FPPE Chart Reviews

FPPE CRITERIA LISTED BELOW. FPPE WILL BE ASSIGNED BY THE SERVICE CHIEF DURING THE APPROVAL PROCESS

5 chart reviews - Core - Applicant must meet with Proctor to discuss completed cases/charts

3 chart reviews - Administration of Moderate Sedation; Electrophysiology studies with or without ablation; Central Venous Catheter Insertion;

5 chart reviews - Cardiac catheterization and Angiography; Temporary transvenous pacemaker placement; Intra-aortic balloon pump placement; Coronary balloon angioplasty and stenting procedures; Endomyocardial biopsy; Peripheral angiography and angioplasty; Carotid Stenting; Permanent pacemaker insert; Pacemaker lead extraction; Implantable defibrillator insertion; Echocardiography interpretation including stress echocardiography and transesophageal echocardiography

3 observations - Management of Cardiac Support Devices; Insertion of Cardiac Support Devices
